**CLOSING: Thursday, October 17, 2024 at 6:00 PM CST, after which time entries cannot be accepted, cancelled, altered, or substituted.**

**DRAWING FOR ENTRIES: Thursday, October 17, 2024, at 6:30 PM CST.** In the event the published limit is exceeded, a drawing will be held at 525 Eagle Landing Drive, Cookeville TN and the public is invited. Entrants will be notified by phone or email promptly after the drawing is complete. Untitled dogs get first preference for the test entered. Entries of AKC TD/TDU titled dogs will be accepted only if the test is not filled by dogs without said title. **Entry forms and checks will be shredded unless otherwise advised by entrant. Entrants shall enclose a stamped self addressed envelope if you wish your entry and check returned.**

**IN THE EVENT AN ENTRANT IS ABSENT on the day of the test,** it shall be the responsibility of the Test Secretary to determine if any alternates are present. If so, space will be filled by such in the order they were drawn.

**LOCATIONS:** Tracks for this test will be offered at Roane State Community College, Harriman.

**TEST WORKER OPTION:** This event will offer tracks to test workers as described in Section 17d. One (1) track in the TDU will be reserved for the test worker option.

**Bitches in Season May Participate** - Bitches in season are allowed to participate only after all other dogs and bitches not in season have participated. Any bitch that appears so attractive to males as to be a disturbing element is considered to be in season. The Test Secretary and Judges must be notified that a bitch or bitches entered are in season prior to the drawing of for the tracks. Please keep the bitch in season confined and away from the tracking site until such time of your drawn track. The last track(s) to be laid shall be reserved for the bitch in season. If there is more than one bitch in season a second draw for these bitches will be held. In the event the handler of a bitch in season does not comply with the conditions above the handler and bitch shall be excused from the test site and any award withheld.
